SPECIFIC FOR CHEMISTS

The following details highlight some of the hazards that may exist in your premises. They are by no means exhaustive and will vary depending on your own particular business.

	MAIN TYPES OF HAZARD	MANAGING THE RISK
STORAGE	Incorrectly stacked goods may fall injuring staff below and overloading shelves/ racks may lead to collapse. Persons climbing on racking to retrieve goods may fall and injure themselves.	Racking should be capable of supporting intended loads and be properly fixed (e.g. Bolted to the floor). Goods should be properly stacked with heaviest items at the bottom. Provide proper safety ladders and training on their use.
MANUAL HANDLING	Lifting and moving stock may cause back injury or muscular strain.	Avoid lifting items which are too heavy - use trolleys, lifts or other devices where possible. Train staff in proper lifting techniques.
MACHINERY AND EQUIPMENT	Persons working at compactors can become trapped or crushed. Faulty shopping trolleys can cause collisions or muscular strains, and selection of the wrong trolley may lead to over-turning injuring users or others.	Ensure machinery is regularly checked, all safety devices are working and that staff are trained to use it properly. Regularly inspect trolleys and take damaged trolleys out of use. Where necessary provide user advice on proper trolley selection.
HAZARDOUS SUBSTANCES	Some items of stock and chemicals used for cleaning, can be harmful.	Store all hazardous chemicals in original containers. Provide staff with training, gloves etc to enable cleaning chemicals to be used safely.
FIRE	Obstructed exit routes, for example by stock and/ or accumulations of packaging, can prevent escape and provide fuel for fires.	Keep all escape routes and fire exits clear, and make regular checks to ensure this is the case. Clear rubbish regularly.
SLIPS, TRIPS AND FALLS	Uneven, slippery or obstructed floor surfaces and trailing cables may lead to accidents and injury.	Keep passageways, delivery areas and stairs clear. Clear up spillages immediately and display warnings of wet surfaces. Fasten cables securely to the floor or en-route overhead if possible.
VIOLENCE TO STAFF	Robbery of goods or cash may place staff at risk of violence.	Consider the use of CCTV panic alarms and other security measures.

PACKAGES

BronzePackage

SilverPackage

All this paperwork will be completed by Benmore and comprehensive to management for Medium and Larger businesses. Under the silver package Benmore's Be Aware products are available for the client. This is at a cost of £10.00 per head for staff and management. Along with this Portable Appliance Testing is offered for clients at £1.50 per plug which will reduce the risk of a fire hazard in the premises. One Half day will be spent on site to carry out the Be Safe paperwork, then one half day in the office to complete the risk assessments and package up a detailed folder that leaves the client fully compliant. The **BeAware** products require one more half day on site to carry out the training and Portable Appliance Testing as well as the Fire Log. All training attendees are awarded with in-house training certificates.

GoldPackage

The gold package opens up all of Benmore's products that are bespoke to the client and leave them fully compliant with all legislation and all paperwork is updated by Benmore to take the hassle, stress and strain away from staff and management for them to focus more on their business. The **BeSafe** products include a Health and Safety policy and Risk Assessments specific to the client, Fire Risk Assessment, Fire Log and Asbestos Management report. All this paperwork will be completed by Benmore and comprehensive to management for Medium and Large businesses. This will also include Benmore's **BeAware** products that are required for the client providing in-house certificates for all attendees on the course for 10 members of staff (£10 per head for additional staff).
